- ★ **Oppose Prisoner Release Programs** – John will fight attempts by liberal federal judges and Sacramento politicians to order California to release felons from jails and prison before they’ve served their time. He will also fight efforts to force taxpayers to give prisoners greater rights and benefits than law-abiding citizens living in free society.
- ★ **Fighting Illegal Immigrant Criminals** – John will demand the federal government repay California taxpayers for the cost of incarcerating illegal immigrants in state prison. If necessary, he’ll sue the federal government to make them pay these costs, transfer the prisoners to federal prison, or arrange for their country of origin to imprison them.

John Eastman is widely considered to be one our nation’s top conservative legal minds. As Dean of the Chapman University School of Law, he partnered with California’s District Attorney’s to establish a special legal program to provide advanced legal training for our front line criminal prosecutors.
